

PRECAUTIONARY STATEMENTS

APPLICATION:

Decco 050 EC is applied at about 1% active ingredient level on washed and damp dried potatoes. The diluted material should be applied using spray nozzles placed evenly across the rollers on which the potatoes are being move.

DILUTION OF THE CONCENTRATE:

Add 1 gallon of Decco 050 EC to 49 gallons of water and mix well. A light brown emulsion will develop.

STORAGE AND DISPOSAL

STORAGE: Keep container closed. Do not contaminate water, food or feed by storage or disposal. This product inhibits germination of seed potatoes.

CONTAINER DISPOSAL: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
